PURPOSE

To develop the Program of facilities projects for the Facilities Master Plan.

DISCUSSION

The FMP Team made a slide presentation, attached.

PROJECT STATUS

The group reviewed the progress to date, including the Planning Themes and a summary of the Existing Facilities Analysis.

Student Voices

The FMP Team conducted a Listening Session with the ASCR Senators on April 11, 2022. Their concerns include:

- We love CR.
- There is no heart of campus activity at Eureka, everyone is on their own.
- We leave the campus because there's nothing to do.
- Vacated buildings look like the apocalypse.
- The Library is closed on weekends, when our homework is due.
- We need access to more group study spaces.
- Internet privacy.

EUREKA CAMPUS

Preliminary FMP Program – Eureka

The group reviewed and discussed the preliminary list of projects.

- 1. Student Resource Center Replacement
- 2. Administration of Justice Renovation or Replacement?
- 3. Academy of the Redwoods Replacement or Relocation (2 portables)
- 4. Library Reprogramming?
- 5. AT Reprogramming?
- 6. Vacate & demolish RBC A & B, Relocate Occupants to Other Facilities
- 7. Demolish and reuse building sites
 - o Creative Arts, Life Science, Physical Science, PE Building, Field House
- 8. Dormitories Replacements

Site Constraints - Eureka

The group reviewed the diagram of site constraints that identify the future, arc-shaped zone for campus development.

- There are two north-south underground utilities line on either side of the AT and Library Buildings. These cannot be building sites.
- A small number of seismically safe sites have been verified by the engineering consultants. These spaces are referred to as "clear" or "cleared."
- It is hugely expensive and lengthy to investigate whether additional sites are safe for buildings, and the answer might be 'No.' The most likely safe sites have already been identified.
- The FMP Team has identified a new, arc-shaped development zone that shifts the center of campus toward the east.
- There are opportunities to replace and reuse sites within that zone.

FMP Projects – Eureka

The group discussed a graphic model showing potential locations for the projects on the programming list.

Tino Romero – The new Library or Student Services Building was supposed to have small study areas for EOPS. They have been repurposed for offices. EOPS is a learning community; these spaces could be regained in a new Student Union. Other uses need to go back to the Student Union.

AT Reprogramming

The building underwent a recent seismic upgrade. Programs include Construction, Auto Tech, Welding, Forestry, Drafting, Solar Tech, Fabrication Lab, Nursing, Dental. Health Sciences occupy the west wing. The Drafting program is 'up in the air.'

What are the unmet facilities needs for CTE programs? Are the programs compatible? Is there room for a maker space?

Julia Morrison – There is a potential to locate/relocate Health Science programs in a joint off-campus space in partnership with Cal Poly Humboldt.

Tino Romero – He will ask Martha Gleebe, former women's coach & CTE administrator about CTE facilities needs.

Tino Romero – What is a maker space? FMP Team: It is a collaborative lab space with facilities and equipment for project-based learning.

Academy of the Redwoods Portables Replacement/Relocation to Existing Space

The two facilities are not DSA approved. There is no foundation. They are not in a 'clear' seismic area.

Redwoods Business Center A and B

The College has documented that the buildings are a life/safety hazard. They are both still occupied by administrative functions, Campus Security, Food Pantry, leased space. Students are not supposed to be allowed in the buildings. They should be vacated and removed. Occupants should be relocated to existing facilities.

Dormitories

The dorms are excluded from the FMP. The College submitted an application for design & construction funding from the Higher Education Student Housing Grant. CR's project was not selected in the first round in 2021. Dr. Flamer is committed to winning funds from this source in the future. FMP Team: It's good that the College submitted its application, and it's good that it was not selected yet. The first round was for a different kind of project. The College wouldn't want to be in that group. It is better for CR's project to be funded in a future round. The FMP will provide important planning information that could strengthen the College's application.

Athletic Fields

Kevin Carter – New construction projects on the southeast side will eliminate the baseball field and the possible the softball field. We need good practice fields. Turf is better than grass for all-weather instruction and practice.

Tino Romero – May the area between the tennis courts and the concession stand is a site for a practice field. Baseball games have been relocated to Redwood Acres. The College has a contract with Bear River. They have a beautiful turf facility, The College needs on-campus practice facilities.

Recently Constructed Facilities

Recent replacements are in good condition, including Student Services, Administration, Performing Arts, Humanities and Science Buildings.

- The College is working on upgrading access control to these buildings.
- There are no major needs other than scheduled maintenance. FMP Team: Deferred maintenance projects over \$500,000 could be included in the FMP.

Student Space

Space in all the existing buildings could be reprogrammed for student space. This would improve the College's space utilization and relieve the 'excess space' in state standard categories.

Instructional Needs

The group needs input from Instruction. Kevin Carter will send contact info to the FMP Team.

Bert Hafer – The Ag program needs facilities improvements. Contact Silas Sarvinsky, Ag Faculty. Kevin Carter will send his contact info to the FMP Team.

FMP Programming Diagram - Eureka

The group discussed potential locations for the FMP program projects.

- Future replacements will need to be stacked (multi-story) because there is limited clear area.
- The sites of future building demolitions are not flat.
- The new center of the campus will be to the north of the Student Services Building.
- 'Flexible space' can be used in more than one way. Often, it can be shared by different programs.

<u>Student Resource Center</u> needs to be replaced in a central location. The center of campus is shifting as development moves to the east. We need an interim cafeteria during construction.

 What happens to the existing SRC site? It could be a future building site, such as a Health Sciences Building.

<u>Academy of Justice</u> - needs to be replaced or the program needs to be relocated to other existing space. It might be difficult to win state Capital Outlay funds for this project because the campus has so much excess space in key categories.

- AR might be replaced near the new Creative Arts Building, with a new dropoff.
- The road near the existing AR buildings is not a loop.
- Should we leave it or move the building?
- AJ needs to be near the new PE Building because they shared spaces.
- The Fire Academy is part of AJ in partnership with Cal Fire Academy. It needs to be included in a replacement AJ facility.
- Paramedics/EMT is also part of AJ, but it is taught with Health Sciences in the Applied Tech Building.
- Show the new tanks on the diagram.

Tino Romero – The gun range is very noisy; it is much-used and the sound is heard all over the campus. It is used for instruction and for practice by local law enforcement. The noise scares some people who are concerned about school shooters. It was constructed with Measure Q funds. FMP Team – it could be moved indoors in a replacement facility.

Julia Morrison – Can we get the AJ site cleared for seismic safety? Michael Perkins is the head of AJ. FMP Team – The softball field is cleared. It is a potential site for an AJ replacement.

<u>Facilities Offices</u> – There is a classroom in this building.

Tino Romero - AJ uses the track, Mat Room and Weight Room in the PE Building. They also use the football field occasionally.

<u>Academy of the Redwoods</u> – programs need to be relocated or replace the portables. It will be difficult to get state Capital Outlay funding for replacement.

<u>Dorms</u> – Student space, dining and dorms need to be co-located in a central location. Could relocate to the site of the softball fields, but it is far from the cafeteria. It could be possible to construct one facility with the Student Union on the ground floor, dorms above.

- The College's housing consultant is Servitas.
- The parking area behind the existing dorms is popular.
- Any construction of dorms must be phased so that students can continue to live on-campus. This is non-negotiable per Dr. Flamer.
- It might be possible to replace the dorms one at a time.

Tino Romero – The co-location of dorms and the Student Union also addressed our DEI concerns.

<u>Athletic Fields</u> could move to the location of the tennis courts and south parts of parking lots E and D, creating a fields complex.

• Could the former location of Creative Arts a potential site for practice fields? FMP Team – it is not big enough for a field.

<u>Botanical Garden</u> – They were recently, finally, able to tap into the sewer and build restrooms

<u>Health and Wellness Idea</u> – Years ago, there was an idea to co-locate the CDC, Nursing and Dental Hygiene.

DEL NORTE

The group reviewed background information about the Del Norte Educational Center.

Listening Session – Del Norte

At the ASCR Listening Session, a student said that the Library has been 'closed for construction' for 2 years, but there is no construction happening. What's the real story?

FMP Program – Del Norte

- 1. Main Building Upgrades roof, mechanical systems
- 2. Modular Replacements

The group reviewed a diagram of modulars to be replaced. The group indicated that it would be better to review this information with Rory Johnson, Dean of Del Norte. He has more information about their needs.

Kevin Carter – will provide contact information for Rory Johnson.

Erik Sorenson – The Library is closed due to a staffing issue.


Eureka Campus Existing Constraints









PURPOSE OF MEETING

To discuss Student Needs & Facilities, and to prepare for the Student Survey.

DISCUSSION

GOALS, THEMES, AND CAMPUS VOICES

The group reviewed project information developed by the Facilities Planning Committee, including Goals, Planning Themes, and comments from College participants in the kick-off interviews.

Campus Voices - Kickoff Interviews

The group reviewed comments by CR administrators, faculty and staff were asked for their input about the needs for facilities improvements to support student success, the College mission, and instructional and service programs. They provided much information about classrooms, labs, offices and support spaces. They also commented on issues that impact students' needs and success outside of class time. We call this "Student Life." Example issues include:

- Lack of hang-out space
- Need space for hand-on learning
- Better WiFi.
- Lack of communal spaces
- No heart of campus activity
- Need better space to collaborate with faculty & staff
- Need spaces for online participation
- Need space to collaborate with educational partners
- CR is a role model for sustainability.

These comments are from non-students; they are shared with this group to start our discussion.

LISTENING: STUDENT VOICES

Questions

In this Listening Session, the FMP Team needs insight from the group about students' perspectives about how the campuses impact the quality of their Student Life outside of class time. Questions include:

- What do you spend time doing on campus outside of class time?
- Where do you do these activities? What facilities work, what doesn't?
- What facility is missing that would enhance your learning experience at CR?
- How does the weather impact your on-campus experience?

Winnifred Carpenter (KT)

• We have on open space on our campus, but nothing is going on, no events.

Sharon Diaz – Eureka

- Beautiful CR I love CR. It is beautiful here.
- Better WiFi We need better WiFi! Access is so spotty on the campus.
- <u>Comfortable Student Spaces</u> We need more comfortable spaces for hanging out, fun, events, interact, study. We have spaces, but many don't work well.
- <u>Library</u> it is hard to work in groups and be quiet at the same time. Group study spaces are too small; there are not enough spaces; they are not available. Also, we need spaces for student meetings and club meetings.
- <u>Dorms</u> I live on campus. We need more dorm rooms. This will bring more people to the College. Especially with football coming back, we need dorms for student athletes. Many students need to live on campus. For some people, if they can't live on campus, or can't afford transportation & off-campus housing, they can't come to CR. It's better to live on campus.

 <u>Limited Library Hours</u> - Study spaces in library only open Monday – Friday, not weekends. Need weekend study space! Social space! Uncomfortable to study in dorms. Can't concentrate. Chat with roommate, phone, etc, distractions. It's really complicated to do homework done on the weekend. The College overlooks the importance of needing spaces to relax, work, concentrate.

Gavin Olson – Crescent City – Del Norte

- <u>Lack of WiFi Privacy</u> Students don't feel they have privacy on WiFi. This is very important to students. They spend their meager funds to purchase a VPN subscription.
- <u>Cell Phones & Internet</u> The coverage is spotty, very difficult to get a signal.
- <u>Library is Closed</u> Library has been 'under construction' for 2 years, since the beginning of the pandemic. I don't see any construction work. I doubt that it's really under construction. What is the story?

Jack Hill

 WiFi Privacy - WiFi access at Del Norte is a major concern to students. The ASCR has had many discussions about it. The College doesn't seem to believe WiFi privacy is a necessity.

Morgan Beebe - Eureka

- <u>VPN, WiFi</u> CR's WiFi is highly monitored, not private. Some students buy cheap VPNs that do not provide good value. It would be very helpful is the College could provide a whitelist of VPN services, maybe arrange a student discount.
- Study Space Late Night, Weekends Often, homework is due at midnight and again on Sunday. It is essential that we have better connectivity and suitable places to study individually and in groups. The Library is not open on weekends.
- Outdoor seating We have picnic benches outside the cafeteria. There are a few benches in that big area between Humanities & Library. It rains 3 times daily. Seating is not covered in the rain. When the sun comes out it's still wet. We need covered outdoor spaces.
- Water Bottle Stations We need water bottle stations! Most students carry refillable water bottles.

Sharon Diaz, Many Others - Eureka

 No Center of Campus Activity - There is no main place on Eureka to hang out and be involved with the student community. There is no campus quad. There is no center of activity. Everybody is on their own.

Sharon Diaz - Eureka

- <u>Student Resource Center</u> Sometimes we hang out in cafeteria inside, or outside by the pond. There is a small seating area outside the cafeteria. Friends held my birthday party here. Security let us be because there was nobody else around to bother.
- <u>Leave Campus to Hang Out</u> We hang out away from campus there is not much to do here.
- Pond Sometimes people hang out by the pond.
- <u>Athletic Fields, Track</u> We like to go to games to be with involved with the student community. we hang out. Also, baseball, track.
- Basketball courts in gym NO! don't mess the floor.
- No Place for a Walk There is no place to take a walk. There is an old trail, but it's closed and it's scary.
- <u>Creative Arts</u> No one hangs there, just go there for class. It's too far from the rest of the campus.
- <u>Science & Humanities</u> A few people hang in Humanities & Science, some tables are placed here and there.
- <u>Library</u> No place to mingle with peers.
- <u>Flagpole/Dropoff</u> This is NOT the heart of campus. It's just a walk-thru place.
 Faculty and staff see high school students linger there while they wait for the bus or for parents to pick them up. Not College students.

PLACES THAT SAY 'STAY AWAY' (Eureka)

- <u>Creative Arts</u> too far, long walk, too exposed. Botanical Garden is there, but people don't know, don't care.
- Woods North of the Dorms There are no trails to use. Doesn't feel safe for a walk.
- <u>Administration of Justice</u> Feels secluded from the rest of the campus. Only AJ students go there; other people are not aware of it.
- <u>Tennis courts</u> Nobody knows it's there. They are secluded from the rest of the campus.
- Field House Not used.








What are your MOST and LEAST favorite places on

campus? Why?




In your opinion, where is the heart of the campus?






