 MINUTES

- 1. **Call to Order:** Peter Blakemore called the meeting to order at 1:01 pm.
- 2. **Introductions and Public Comments:** There were no public comments.
- 3. **Approve May 4, 2018 Academic Senate Minutes.** On a motion by Todd Olsen, seconded by Mike Richards. The minutes of May 4, 2018 were unanimously approved as emended. Corrections to agenda item 6.4, edit the last bullet to read 'act'.
- 4. Action Items:
 - 4.1 **Approve Academic Senate Committee Nominations:** Peter Blakemore was available for questions. On a motion by Mike Dennis, seconded by Wendy Riggs, the Academic Senate Committee Nominations were unanimously approved by roll call vote.
 - 4.2 Approve Academic Standards and Policies Committee (ASPC) Revisions to AP 4231 Grade Changes: Karen Reiss was available for questions. On a motion by Todd Olsen, seconded by Wendy Riggs, the Academic Senate Committee Nominations were unanimously approved as emended by roll call vote. The document to be emended in page one, second paragraph, first sentence: 'to resolve the matter informally' strike informally and emend to, 'through direct communication between the student and the instructor.' In the next sentence where it says informally meet, strike informally.
 - 4.2.1 AP 4231 Clean Copy
 - 4.2.2 AP 4231 With tracked edits
 - 4.3 Approve 2018-2019 Faculty Development Funding Resolution: Peter Blakemore was available for questions. There were questions regarding why the funding amount is less than last year. Angelina Hill stated that she believed the funding should not be less. On a motion by Todd Olsen, seconded by Wendy Riggs, the committee unanimously agreed to table the Faculty Development Funding Resolution until the funding amount was confirmed.
- 5. Discussion
 - 5.1 **Senate Apportionment: 2017-2018 Review:** Peter Blakemore stated that on April 15th full time faculty should be reviewed for their distribution throughout their divisions in

order to determine the number of senators required to represent each division per the Senate Constitution. An additional senator was added from Del Norte based on this requirement. This will come back as a discussion on a future agenda with potential for constitution changes.

- 5.2 **Committee Appointment Process:** Peter Blakemore discussed the need for simplifying the process of committee assignments. Suggestions were made for committee chairs to inquire within their committees prior to the end of the semester to determine who is continuing and which seats need filled. Angelina stated that the new contract contains the F0 which asks faculty about their committee services. Peter Blakemore stated that faculty should list committees that are mission critical on their F0 form and put in a request with their Dean to have this count towards their committee requirements.
- 5.3 **Senate Plenary:** Peter Blakemore stated that there were not senators in attendance last year and it is important to have representation. He informed senators that a representative can be sent from the senate. Todd Olsen suggested that two senators are sent in order to represent different divisions. The fall plenary will take place November 1st through November 3rd in Irvine. This may be put on the agenda as an action item for the next meeting.
- 5.4 **Senate Membership Expansion for KT:** Stuart Altschuler stated that since decisions are made in Senate that affect faculty in all locations that there should be a senate member from KT. S. Altschuler stated that he would like to have the discussion about updating the bylaws to reflect. There was concern from committee members about how this could affect the number of Senate seats. It was additionally discussed that KT is a site, not a campus. Concerns were raised that if we added a senator for KT then many other areas could want a seat. S. Altschuler requested the information of the equivalency of the part time faculty as full time faculty based on FTEs. It was suggested that this be discussed with the apportionment discussion.
- 2018-2019 Senate Priorities: Peter Blakemore requested that senators let the Copresidents know of items that they felt the senate should be discussing over the 2018-2019 term. Senators were asked to email Peter Blakemore, Gary Sokolow, and Jessica Frint with their thoughts and suggestions.

6. Reports

- 6.1 Associated Students of College of the Redwoods (ASCR) Update: ASCR Representative. There was no ASCR Representative in attendance. Gary Sokolow informed Senators that Joshua Mata would be the representative for 2018-19.
- 6.2 **Guided Pathways and the New Funding Formula:** Angelina Hill gave a brief summary of the funding formula. She gave an overview on how the new formula differs from the prior formula. Questions were also asked about if there was a mechanism on awarding degrees that students didn't apply for. A. Hill stated that auto-awarding has money allocated for this.
- 6.3 **College Update:** Angelina Hill stated that there were 118 sections identified as Zero Textbook Cost (ZTC) which was more than expected. She mentioned that there would be campaigning to familiarize the symbol for ZTC and for the Low Textbook Cost symbol (LTC) as well. She also reported that the President is charging a task force to identify

what a 'good' bookstore would look like and this would involve Senate. Senators asked if the contract could potentially be renewed without input from faculty. A. Hill stated that the alternative needs to be determined for this not to happen. Senators requested that this be a discussion item for the next senate meeting. She also reported that there will be a 4021 request for input on Agriculture and Digital media programs to go to the entire college community for input. Additionally she reported that Philp Mancus is discussing putting together a new task reviewing new assessment software. She reported that meetings about Dual Enrollment are being held. She mentioned that there are challenges with the timing and scheduling with the high schools.
