Kristy Carlsen explained that Speaking exercises require a lot of guidance and practice with speaking activities. Facilitating this via a live zoom session (with breakout rooms for pairs/small groups), and the instructor can move around and check in with different groups. The alternative would be assigning students to communicate one on one on their own, which Carlsen feels is insufficient pedagogically.

#### 5. Discussion

5.1 Guided Pathways and Curriculum – Marla Gleave

Marla Gleave and Angelina Hill shared their views regarding the question of how best to integrate Guided Pathways perspectives into our curricular and program development processes. Additionally, Gleave explained the basic framework of the Guided Pathways initiative and commented on the importance of clarity and consistency regarding the word "transfer"; additionally, she suggested that faculty would benefit from additional training and consultation with Counseling and Advising to reinforce their understanding of appropriate terminology and the perspectives and needs of students.

Gleave and Hill suggested that the Articulation Officer would the appropriate point person to facilitate early dialog between faculty developing programs, initiative leaders on campus, and counseling and advising folks in order improve how our program designs serve students and support their success.

Sean Thomas noted that absent such a point person, Jennifer Burlison stepped up to facilitate that dialog with the SWHS program, and that placed an unreasonable burden on her work as a Curriculum Committee member.

Courtney Loder agreed that fully engaging the Articulation Officer in such processes would be a wise idea.
