

**Group Discussion-** Each group will have one short group presentation worth 15% of your overall grade. These presentations will be based on each groups assigned case study. Each group will lead a discussion with the class on your case, the required time for this assignment is 20 minutes.

**Weekly Activities-** Each week you will be assigned readings and activities to be completed in Canvas. They will be due every Sunday evening.

Quizzes- Quizzes will be completed during class time.

Midterm and Final- The dates of the midterm and final will be in the course schedule.

**Final Presentation**- Final presentation will be on a project that we will be working on all semester long. This is a group project. More details are to follow.

# Klamath Trinity Campus Emergency Procedures

  - 2. In the event of an emergency, the responsible district employee on scene will:
    - a. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet.
    - b. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
    - c. Close all window curtains.
    - d. Get all inside to safe location Kitchen area is best internal location.
    - e. If a police officer or higher official arrives, they will assume command.
    - f. Wait until notice of all is clear before unlocking doors.
    - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
    - h. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)
