Methods of Evaluation: The final grade you receive will be based on the following criteria:

Grading Methods:

Each assignment is graded separately for each student, meaning there is no curve. For each incorrect portion of the drawing, ½ a point will be deducted from the drawing's grade. This can be changed depending on the severity of the mistake by the instructor.

Participation is based on taking a quiz on Canvas at the beginning of each class. Students will have 10 minutes total for the quiz; 5 minutes prior to the start of class and 5 minutes after the beginning of class. Students will get 2 points on each quiz regardless of answering questions correctly or not. If a student leaves early, they will lose 1 point. At the end of the semester, the instructor may add or subtract points depending on class participation and attitude.
