Course Requirements (subject to change with fair notice):

ENGL-53A may be taken for a grade of “P” (pass) or “NP” (no pass) only. This course is not repeatable.

To pass the 1-unit class, students must attend a minimum of 45 hours during the semester, have two tutoring sessions with an instructor or senior tutor to get assistance and feedback on a reading or a writing assignment, and take the online Self-Assessment Survey available on Canvas. All three requirements must be fulfilled to receive credit.
