Course Requirements (subject to change with fair notice):

ENGL-54 may be taken for a grade of “P” (pass) or “NP” (no pass) only. This course is not repeatable.

To pass the ½-unit class, students must attend a minimum of 22.5 hours during the semester, have one tutoring session with an instructor or senior tutor to get assistance and feedback on a reading or a writing assignment, and take the online Self-assessment Survey available on Canvas.
