### Catalog Description

Study argumentation and critical thinking in this second-semester composition course focused on reading and writing across multiple academic communities. Practice critical reading and research strategies, examine and evaluate primarily nonfiction texts, and craft responses through argumentative writing. Strengthen your information literacy and documentation skills and satisfy both the full-year composition and the critical thinking transfer requirements.

### Course Student Learning Outcomes *(from course outline of record)*

1. Analyze argumentative claims.
2. Respond to arguments with persuasive critical essays. Locate, synthesize, and document sources for use in response to arguments.
3. Demonstrate the capacity to read, analyze and evaluate non-fiction texts in support of academic inquiry and argumentation.
4. Utilize flexible strategies for writing expository and argumentative college-level essays.
5. Incorporate primary and secondary sources into essays using appropriate documentation format.

## Evaluation & Grading Policy

**Coursework:** Each week, you will be responsible for accessing Canvas to view the current schedule (located in the weekly modules) and plan ahead for a timely completion of the reading and writing assignments. Time management and organizational skills are absolutely essential in the online learning environment. All homework activities, class discussions, and formal papers build on one another and emphasize cumulative learning. You must then stay connected, informed, and on track. When in doubt, communicate with me directly and make sure you submit everything on time. Your own success in the course depends on it! Individual assignments must be uploaded to Canvas where they will be evaluated and graded according to published requirements. Students can monitor their own progress in the course by periodically checking their grades on Canvas and contacting the instructor when they have questions. As per CR English Department policy, extra credit is not available. Course grades are earned by fully participating in class and by successfully completing all required assignments.

**Late assignment policy:** You have one week from the assignment due date to submit late work and still receive credit AND feedback. After one week, you will still receive credit, but no feedback. I reserve the right to not accept work more than two weeks late.

- Content readings and MRLs (turned in in-class) 25%
- Discussions (attendance and reflection, in-class) 25%
- Practice Essays and Formal Essays (Components and Drafts) (submitted on Canvas) 40%\*
- Quizzes (on Canvas) 10%

1. Evaluate the impact the emergency has on your activity/operation and take appropriate action.
2. Dial 911, to notify local agency support such as law enforcement or fire services.
3. Notify Public Safety 707-476-4111 and inform them of the situation, with as much relevant information as possible.
4. Public Safety shall relay threat information, warnings, and alerts through the Everbridge emergency alert system, Public address system, and when possible, updates on the college website, to ensure the school community is notified.
5. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet, (evacuation to a safe zone, shelter in place, lockdown, assist others if possible, cooperate with First Responders, etc.).
6. If safe to do so, notify key administrators, departments, and personnel.
7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.

### **Klamath Trinity Campus Emergency Procedures**

Please review the responsibilities of, and procedures used by, the College of the Redwoods, Klamath-Trinity Instructional Site (KTIS) to communicate to faculty, staff, students and the general public during an emergency. It is the responsibility of College of the Redwoods, Klamath-Trinity Instructional Site (KTIS) to protect life and property from the effects of emergency situations within its own jurisdiction.

1. In the event of an emergency, communication shall be the responsibility of the district employees on scene.

- a. Dial 911, to notify local agency support such as law enforcement or fire services.
  - b. If safe to do so, notify key administrators, departments, and personnel.
  - c. If safe to do so, personnel shall relay threat information, warnings, to ensure the school community is notified.
  - d. Contact 530-625-4821 to notify of situation.
  - e. Contact Hoopa Tribal Education Administration office 530-625-4413
  - f. Notify Public Safety 707-476-4111.
2. In the event of an emergency, the responsible district employee on scene will:
- a. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet.
  - b. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
  - c. Close all window curtains.
  - d. Get all inside to safe location Kitchen area is best internal location.
  - e. If a police officer or higher official arrives, they will assume command.
  - f. Wait until notice of all is clear before unlocking doors.
  - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
  - h. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)
