# **Evaluation & Grading Policy**

There will be 1000 points possible over the course of the semester. Class grades will be assigned based on the following cut-offs: 930 is an A, 900 is an A-, 870 is an B+, 830 is a B, 800 is a B-, 770 is a C+, 700 is a C and 600 is a D. You will earn these points through:

<u>Journals</u>: (200 points possible, thus 20% of your final grade) For each of the ten Chapters, I will assign at least one of the Journal Entries from the textbook. Each Journal Entry will be worth up to 20 points and you can earn up to 40 points in a week if you do two Journal Entries in a week. This will allow you to make up points if you miss a week's work.

Your journal entries should be approximately 250 words in length and written in complete sentences with proper grammar and spelling.

Unless noted otherwise, Journal Entries are due midnight on Sunday. In some cases, I may send you a follow-up question on your Journal Entry via Canvas messaging. Answering my follow-up question will be worth up to 10 points.

<u>Discussion Forum:</u> (Up to 10 points possible per week for up to 10 weeks, so 100 points possible, thus 10% of your final grade). Each week, you'll have two options for class participation – the Canvas discussion forums or attending a Zoom discussion.

• <u>Option A</u>: By 9 am Monday each week, I will post one or more discussion prompts to a weekly discussion forum.

Your response to my initial question will be worth up to 4 points and is due by midnight Wednesday. Responding to a classmate's initial post will be worth up to 3 points per response and your responses are due by midnight on Sunday.

• <u>Option B</u>: (Experimental) I will experiment with hosting two Zoom discussion sessions per week. <u>This</u> will be a discussion, not a lecture. You can earn 5 points by attending one of the sessions. You can upgrade that to 10 points by actively participating in the session.

You can show evidence that you prepared for the discussion by attempting the week's Canvas quizzes and bringing questions about parts of the quiz that were tricky for you. You can also show evidence that you prepared by looking at the questions in the discussion forum and coming prepared to discuss those verbally.

Right now, I am planning on the sessions to be 10 - 11 am Wednesdays and 1-2 pm on Thursdays. If not many students are interested in this option, I may reschedule these sessions or abandon this option.

Each week, you can choose to share a journal entry with the whole class for an optional 10 extra credit points. Your share is due the Sunday after the journal entries are due.

<u>Career Exploration Interviews</u>: (100 points possible, thus 10% of your final grade.) For this assignment, you will interview someone about their current or former employment. You will do two interviews, each worth 50 points.

<u>Final Project</u>: (600 points possible, thus 60% of your final grade.) The final project will consist of three major parts. For each part, you will submit a draft worth 50 points. At the end of the semester, you will resubmit a final version worth 450 points that incorporates my feedback on your draft versions.

Part 1: Personal background, values, priorities, and lifestyle. For this portion of the project, you will be describing who you are and what your background is, what your personal values/priorities are, and what kind of lifestyle will feasibly allow you to live out your values and priorities. *Draft due November* 8<sup>th</sup>.

Part 2: Career and Academic Plan: For this portion of the project, you will identify and research several jobs/trades/careers, their employment potential, and what types of education and training you will need to obtain an entry level job in that field. *Draft due November 22<sup>nd</sup>*.

Part 3: Student Education Plan: For this portion of the project, you will map out what courses you will take in each semester at CR to allow you either obtain an entry level job in your chosen field or transfer to a four year school in your chosen major. Draft due December 6<sup>th</sup>.

Final Draft: This include revised versions of the 3 draft parts. Due December 20<sup>th</sup>.

In the event of an emergency:

- 1. Evaluate the impact the emergency has on your activity/operation and take appropriate action.
- 2. Dial 911, to notify local agency support such as law enforcement or fire services.
- 3. Notify Public Safety 707-476-4111 and inform them of the situation, with as much relevant information as possible.
- 4. Public Safety shall relay threat information, warnings, and alerts through the Everbridge emergency alert system, Public address system, and when possible, updates on the college website, to ensure the school community is notified.
- 5. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet, (evacuation to a safe zone, shelter in place, lockdown, assist others if possible, cooperate with First Responders, etc.).
- 6. If safe to do so, notify key administrators, departments, and personnel.
- 7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.

# Klamath Trinity Campus Emergency Procedures

Please review the responsibilities of, and procedures used by, the College of the Redwoods, Klamath-Trinity Instructional Site (KTIS) to communicate to faculty, staff, students and the general public during an emergency. It is the responsibility of College of the Redwoods, Klamath-Trinity Instructional Site (KTIS) to protect life and property from the effects of emergency situations within its own jurisdiction.

- 1. In the event of an emergency, communication shall be the responsibility of the district employees on scene.
  - a. Dial 911, to notify local agency support such as law enforcement or fire services.
  - b. If safe to do so, notify key administrators, departments, and personnel.
  - c. If safe to do so, personnel shall relay threat information, warnings, to ensure the school community is notified.
  - d. Contact Jolene Gates 530-625-4821 to notify of situation.
  - e. Contact Hoopa Tribal Education Administration office 530-625-4413
  - f. Notify Public Safety 707-476-4111.
- 2. In the event of an emergency, the responsible district employee on scene will:
  - a. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet.
  - b. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
  - c. Close all window curtains.
  - d. Get all inside to safe location Kitchen area is best internal location.
  - e. If a police officer or higher official arrives, they will assume command.
  - f. Wait until notice of all is clear before unlocking doors.
  - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
  - h. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)
