# **Course Description**

A review of Elementary Algebra ("Algebra I") material as preparation to enter Intermediate Algebra (MATH 120 or MATH 194). This course is recommended preparation for students taking the mathematics assessment test to qualify for MATH 120 or MATH 194. This late-start class meets TTH for four weeks only (2/28/17-3/30/17). This class involves extensive computer work. MATH 302 is a "Math Jam" course. http://mathrev.redwoods.edu/mathjam/

#### **Student Learning Outcomes**

Demonstrate the skills required to pass the placement exam which will allow the student to enroll in the proper level of mathematics. This will be assessed at the end of each module. These assessments will include: polynomials, linear equations, graph interpretation, and problem-solving techniques.

#### **Review Course**

## Course Goals

- 1. If you are registered for, or cleared to take, MATH 120 or MATH 194 next semester, and if you simply want to review, it is recommended that you complete all the exercise sets and receive passing grades (70% or better) on all quizzes at the end of each module.
- 2. If you would like to test out of MATH 380 and take MATH 120 or MATH 194 in the future, it is recommended that you complete all the assignments and receive at least 80% on all quizzes at the end of each module. You will also be required to take a placement exam, which is offered outside of class. Based on the results, you will either be granted placement into MATH 120 or MATH 194 or keep your current placement in MATH 380.
