Students receive on-on-one and small group instruction designed to enhance success in transfer level mathematics (or similar course).

Note: Students should be enrolled in transfer level mathematics or similar course. Every 1.0 unit of LAB requires 54 hours (45 actual 60-minute hours is equivalent to 54 "classroom" 50-minute hours).
