#### Weekly Module Discussions/Activities

Your presence and participation in the weekly module discussions and activities is essential for making this class successful. Your participation informs me, and you, as to whether you are gaining an understanding of the material. They also provide an opportunity for you to build your understanding of and use of mathematical thinking and reasoning.

There will be one or two of these in each weekly module. You can complete these each week during regularly scheduled office hours or are scheduled Math 5 coffee chat. Each will be worth 10 points. These cannot be completed late and submitted for credit.

#### Homework

There will be a 20 point homework assignment in each weekly module. The homework may consist of online practice (using MyOpenMath linked through Canvas) or a written/typed assignment you submit through Canvas as a pdf or some combination. Here you'll be able to practice and get immediate feedback about how you are doing at understanding the mathematical skills and reasoning we have been studying. I accept these up to one-week late, however there is a late penalty. For MyOpenMath assignments you will receive 70% of the points earned for each question answered submitted correctly after the due date. For non-MyOpenMath assignments, you will receive 70% of the credit if submitted late.

#### **Unit Projects**

A Unit Project will be due at the completion of each unit we cover. See the Tentative Calendar below for when these are due. The Unit Project will evaluate your understanding and ability to apply mathematics to contemporary issues. More information on each of these will be given at the start of each unit. Unit Projects received up to a week late will be assessed a 10% penalty. Unit projects over a week late can receive a grade of no more than 75%. Non-passing projects, except the last unit project, may be resubmitted once for at most 75%. No Unit Projects will be accepted after Friday 5/14/2021.

- 7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.

#### Klamath Trinity Campus Emergency Procedures

- 2. In the event of an emergency, the responsible district employee on scene will:
  - a. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet.
  - b. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
  - c. Close all window curtains.
  - d. Get all inside to safe location Kitchen area is best internal location.
  - e. If a police officer or higher official arrives, they will assume command.
  - f. Wait until notice of all is clear before unlocking doors.
  - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
  - h. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)
