# **Catalog Description**

A course for students studying in science, technology, engineering, and mathematics (STEM) fields. Both Math 25 and Math 30 (College Algebra), are prerequisites for Math 50A (Differential Calculus). Topics include: A study of trigonometric functions, radian measure, solutions of right triangles, graphs of trigonometric functions, inverse trigonometric functions, trigonometric identities and equations, Law of Sines, Law of Cosines, solutions of oblique triangles, polar coordinates, complex numbers in trigonometric form, De Moivre's theorem, and an introduction to vectors. Note: Graphing technology may be required in this course.

#### **Course Student Learning Outcomes (from course outline of record)**

- Apply the mathematics of trigonometric functions to real-world problems and applications.
- Create and analyze graphs of trigonometric functions and polar curves.
- Write solutions to mathematical exercises in trigonometry using sound mathematical reasoning with appropriate use of numerical, graphical, and symbolic representations.

- 5. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet, (evacuation to a safe zone, shelter in place, lockdown, assist others if possible, cooperate with First Responders, etc.).
- 6. If safe to do so, notify key administrators, departments, and personnel.

7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.
