### Catalog Description (Math 15)

An introduction to basic concepts of descriptive and inferential statistics, with emphasis on the meaning and use of statistical significance. Students will use probability techniques to make decisions via hypothesis testing and will estimate parameters using confidence intervals. The course includes applications from a variety of technical and social science fields.

### Course Student Learning Outcomes (Math 15)

1. Accurately communicate statistical ideas using correct statistical notation, graphs, and vocabulary.
2. Use descriptive and inferential statistics to better understand real-world problems.
3. Demonstrate appropriate use of technology in making decisions based upon real-world data.
4. Read and interpret information that contains statistical analysis and be able to communicate these results.
5. Judge the validity of research reported in the mass media and peer reviewed journals.

Completion of Intermediate Algebra or appropriate placement based on AB 705 mandates.

## Evaluation & Grading Policy

Your grade in this course will be evaluated in 4 ways:

1. **Online Homework (10%)** – You will be assigned an online homework assignment on Canvas. These online assignments will work like any other online homework system except you will access it through Canvas rather than directly through MyOpenMath/Optimath.
2. **Lab Reports (25%)** – We will be having Lab days where we work on statistical problems using the computer. Each lab day, I will give you a set of questions that you must answer on the problem we are working on. You might finish these during the lab, or you might have to take them home to finish. That will depend on the lab. Also later in the semester, you will instead have statistical studies that you will be assigned to read and write an interpretation of in your words.
3. **Written Homework/Quizzes (25%)** – For each chapter of the book, I will assign you problems that you must write up the answers to. These will be due when we finish the chapter. We will also have Quizzes after we finish each chapter of the book. You will be able to use your written homework for that chapter as notes on the Quiz. The quiz questions will closely resemble a small selection of the homework problems.
4. **Tests (40%)** – We will have two tests in the class. One in the middle of the class, which I will announce the date of at least two weeks prior. Then another one during our final period.

4. Public Safety shall relay threat information, warnings, and alerts through the Everbridge emergency alert system, Public address system, and when possible, updates on the college website, to ensure the school community is notified.
5. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet, (evacuation to a safe zone, shelter in place, lockdown, assist others if possible, cooperate with First Responders, etc.).
6. If safe to do so, notify key administrators, departments, and personnel.
7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.

## **Klamath Trinity Campus Emergency Procedures**

Please review the responsibilities of, and procedures used by, the College of the Redwoods, Klamath-Trinity Instructional Site (KTIS) to communicate to faculty, staff, students and the general public during an emergency. It is the responsibility of College of the Redwoods, Klamath-Trinity Instructional Site (KTIS) to protect life and property from the effects of emergency situations within its own jurisdiction.

1. In the event of an emergency, communication shall be the responsibility of the district employees on scene.
  - a. Dial 911, to notify local agency support such as law enforcement or fire services.
  - b. If safe to do so, notify key administrators, departments, and personnel.
  - c. If safe to do so, personnel shall relay threat information, warnings, to ensure the school community is notified.
  - d. Contact 530-625-4821 to notify of situation.
  - e. Contact Hoopa Tribal Education Administration office 530-625-4413
  - f. Notify Public Safety 707-476-4111.
2. In the event of an emergency, the responsible district employee on scene will:
  - a. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet.
  - b. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
  - c. Close all window curtains.
  - d. Get all inside to safe location Kitchen area is best internal location.
  - e. If a police officer or higher official arrives, they will assume command.
  - f. Wait until notice of all is clear before unlocking doors.
  - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
  - h. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)
