Course Description:

A course addressing both the philosophic roots and the contemporary operation of American national, state, and local government. Specific topics include constitutional development, federal-state relations, and the rights and obligations of citizens under both the federal and the California constitutions.

Student Learning Outcomes:

- **1.** Explain the history and philosophy of the Constitution, politics, and government in the United States.
- **2.** Identify the major provisions of the California and US Constitution.
- **3.** Compare the three branches of California and US Government, and related political institutions.
- 4. Outline the relationship between the states and national government (ie. federalism).
- 5. Analyze contemporary issues facing California and the US system of government.

COURSE RECOMMENDATIONS AND EXPECTATIONS

Recommendations: I highly recommend students are eligible or have taken English 1. This course does involve writing essays and you are required to use citations (MLA, APA or Chicago Manual of Style). You are required to not only provide a bibliography or works cited page, but also endnotes, footnotes or in-text citations throughout your writing assignments.

Instructor Expectations: Students should be aware that a considerable amount of reading, web research, and other work will be required as preparation for each class session. It is anticipated that, in order to receive a passing grade, a minimum of 3 to 5 hours will be required to prepare for each class session. Additional time will be needed to prepare for the mid-term, final, complete homework and writing assignments and specific in-class assignments. At a minimum, students are expected to:

1. Prepare carefully before coming to class. Preparation includes doing the assigned reading, completing any assignments, thinking about the material, and bringing questions and comments to class.

2. Expect that most of the work will be interesting and stimulating, and contribute to making it so.

3. Keep abreast of current events. This includes regularly reading the news section of at least one newspaper.

4. Show up on time. Do not make other appointments during class hours.

Please note that the issues covered in the course are, by their nature, controversial, and therefore can arouse deep feelings. In our quest to understand all sides of these hotly contested issues we need to respect the rights of others to hold and express their beliefs.

Supplemental readings are listed for some weeks. Additional readings and/or activities will be assigned and handed out in class from time to time. It is the student's responsibly to know what readings/activities are assigned. The readings and handouts are intended to help broaden your understanding of classroom discussion.

Course Outline & Dates:

You will need to attend class (or contact a fellow student if you miss class) to find out which chapter we will be reviewing and the corresponding homework quiz that is due. The due dates for the papers and exams are fixed, but the homework quiz due dates will just depend on how quickly we get through each chapter. <u>Plagiarism Quiz:</u> The plagiarism quiz is due the second week of class. I will give you a handout with instructions in class.

Paper 1 and 2: The details of these written assignments will be handed out in class and will also be posted in MyCR. Each is worth 100 points. These will be available under the assignment link (full description of the assignment and its requirements will be posted there). For the assignments I require double spaced, size 12 font, Times New Roman or Calibri black font only. You must cite the source of <u>all</u> information used in your paper (MLA, APA or Chicago). <u>You must provide citations throughout the body of your paper using one of these citation styles. A bibliography or works cited page is ALSO required in addition to the citations within the body of the paper.</u>

Homework Quizzes: The homework quizzes will be short, multiple choice quizzes that you will take before class on MyCR. Before we begin covering a particular chapter, you must take the posted homework quiz, print the results, and bring them to class to receive credit. For some chapters an in-class assignment will be given in place of a quiz. Make-ups will not be allowed. There will be a total of 200 points made available to you as part of pop-quiz or in-class assignments. However, you only have to accumulate 140 "quiz" points. That means you can miss a few quizzes or in-class assignments and still accrue 140/140 points.

News Response Assignment: This assignment requires you to give a short presentation in class on a news article of your choice. You choose the date to present (max of 2 presentations per class period). Details are in the assignment link in the MyCR class website.

<u>Midterm/Final</u>: The midterm and final will be made up of term definitions and essay questions. A study guide will be provided at least two weeks in advance (if not earlier).
