## **Course Description**

The goal of this course is to give students a relevant understanding of how our complex government operates by describing the basic ideas, structure, and influences (parties, PACs), on our government and how politics works. This course addresses both the philosophic roots and the contemporary operation of American national, state, and local governments. Specifically, we will discuss constitutional development, federal-state relations, and the rights and obligations of citizens under both the federal and the California constitution.

## **Student Learning Outcomes**

Upon successful completion of this course students will be able to:

- -Explain the history and philosophy of the Constitution, politics, and government in the US;
- -Identify the major provisions of the California and US Constitutions;
- -Compare the three branches of the California and US Constitutions, and related political institutions;
- -Outline the relationship between the states and national government (Federalism); and
- -Analyze contemporary issues facing California and the US system of government.

## **Course Description**

The goal of this course is to provide you with a relevant understanding of how our government operates by describing the basic ideas, structure, and influences on our government and how politics work. Specific topics include constitutional development, federal-state relations, and the rights and obligations of citizens under both the federal and California constitutions. We will explore how influence directs policy and outcomes from groups such as political parties, political action committees (PACs), media, special interests, and the general public. You will become familiar with policies, foreign and domestic, and how policy is made. We will discuss current news events such as terrorism, healthcare, and the 2016 presidential election showing how they connect with the many institutions within our political system.

**Class format** consists of lecture, discussions, and activities.

There will also be various articles and handouts that will either be provided, placed on Canvas and/or a link will be given.

# **Expectations**:

- 1. Class will begin on time each Monday and Wednesday at 1:15 pm and last until 2:40 pm. Please be ready on time and prepared to discuss the assigned readings.
- 2. You are expected to take the midterm, final, and all quizzes on the dates they are scheduled. Only under the most extreme of circumstances, to be determined by the instructor, will there be any deviation.

- 3. Cellphones will not be used during class; this includes texting and messaging on a computer. Please turn your cellphone ringers off prior to class. If you are found to be disruptive with your phone you will be asked to leave and will lose participation credit for that specific session.
