Catalog Description

1. Weekly Discussion Forums: All students will be expected to participate in answering and commenting on all 24 discussion questions. This is an opportunity for all students to discuss the weekly political questions, and to express their opinions. An open forum for political discussion means that all students should feel free to express their opinions and respect the opinions of others. Students are encouraged to comment on the posts of other students. The discussion questions can be found in the *Discussion* section in Canvas.

2. Written Assignments (Reports): There are two (2) written assignments (reports) that should be typed (double-spaced). The written assignments (reports) are identified in the syllabus. Further details on the requirements for each written assignment (report) is provided in the *Assignments* section in Canvas.

3. Mid-Term Exam: The exam will cover course materials (reading assignments, lecture notes, discussion topics, etc) addressed through Lecture 10 (Week 8). The exam is 90 minutes (1 1/2 hours) long, consisting primarily of multiple choice, true-false, and short-answer essay questions. The Exam will appear in the *Quizzes* section of Canvas.

4. Final Exam: The exam will cover course materials (reading assignments, lecture notes, discussion topics, etc) addressed after Lecture 11 (Week 9). The exam is 90 minutes (1 1/2 hours) long, consisting primarily of multiple choice, true-false, and short-answer essay questions. The Exam will appear in the *Quizzes* section of Canvas.
