Course Description

A course that has a focus in applied psychology. The course surveys psychological theories and empirical research as applied to personal growth, personality development and adjustment. The topics covered include: personality development, self esteem, stress and coping, health, psychology of love,

sex and sex roles, mental health diagnoses, work and group behavior. Students will learn to apply psychological theories and principles to their own lives. Students are asked to look at their own barriers to personal effectiveness in learning, work and interpersonal relationships.

Student Learning Outcomes

1. Explain concepts in areas of psychological theory and research while utilizing appropriate terms to respresent the biopsychosocial perspective.

2. Analyze psychological research and apply concepts to self and others in writing for life-long personal growth.

3. Critically analyze psychological information in the popular press.

4. Describe specific research methods and the general principles of research ethics for the study of human beings, including the safeguards and the peer-review process in science

Assignment Guide

Canvas Discussion (5 points each - 60 points)

Write a discussion post in canvas reflecting on the chapter assigned. The paragraph should identify something in the chapter you found interesting, why it was interesting, and how you have observed the topic in reality...1. Interest 2. Explanation 3. Application.

*Extra Credit Opportunity: For every chapter you can receive extra credit for responding to a peers' discussion post. The response must be made within 2 weeks of the discussion post. You will receive 1 point for each discussion you respond to. You may receive up to 3 points per chapter. However, you cannot take advantage of this opportunity if you do not complete your reflection discussion assignment.

Research Paper Outline (10 points)

The outline should identify the topic of research as well as the subtopics you intend to explore to support your question.

Annotated Bibliography (15 points)

The Annotated bibliography should include at least 3 references and no more than 5 references, which you will use in your research paper. The references must be listed in APA format. The reference is followed by a paragraph paraphrasing the content of the literature. You are encouraged to use peer reviewed articles, News articles, or other published books to research your topic. Please refrain from using Wikipedia.

Literature Review (50 points)

You will explore a topic of your choice. You may choose to research any topic covered within the textbook. The literature review must be at least 3 pages and no more than 5 pages. The paper must follow APA format, using 12 pt, times new roman font, double-spaced. You must cite at least 3 references in your literature review.

Personal Reaction/Experience (25)

In this assignment, you will write about the lived experience of your topic. You are encouraged to share your own experience, or interview a friend. You may also discuss the lived experience of a celebrity or historically famous person. This paper should be 2-4 pages in length. If you use the lived experience of a celebrity or historically famous person, you must cite the source at which you obtained the information.

Research Paper (50 points)

The Research Paper will combine your literature review and personal reaction paper, and then tie them together with a discussion and conclusion section. While this paper combines your first two writing assignments, for this assignment you will have incorporated all feedback given by the instructor, fixing all grammar/spelling errors.

Presentations (50 points)

You will select a topic in the first two weeks of class. This topic should be the topic you plan to use for your reaction paper. The presentation is a 5-10 minute presentation, which should introduce the topic to the class, define terms, and share an example of how the topic manifests itself in reality. The example shared can be your own experience, or that of a friend, family member, or celebrity. If you would like to be more creative in this assignment, you are welcome to share an original art piece, poem, monologue...etc in lieu of a personal experience narrative as long as the creative product highlights the psychological aspect of the topic chosen. Another option for your presentation is an APA style poster presenting your research findings. The poster should utilize visual aides such as pictures or graphs to display your findings. The poster should provide a brief review of your citations; this can be achieved through images, graphs, or quotations.

Take Home Exams (THE) (10 points each - 40 points total)

Every three chapters you will have a Take Home Exam. There will be 5 short answer questions on each exam. These exams are designed to help you solidify the material as you apply, compare, and contrast the information between in class exams. You are welcome to use your book and any notes during these THE's. (③)

Exams (75 points each 150 points total)

There will be two exams in this class. The first exam will cover chapters 2-7. The second midterm will cover chapter 8-13. During the class before each midterm, the instructor will briefly review the material and answer questions regarding the chapters. You may NOT use notes, or a cheat sheet for these exams. The midterms must be completed in class on the day of the midterm, unless previously arranged with the instructor.

Final (150 points)

The final will be cumulative, covering all studied chapters of the textbook. The final will cover chapters 2-13 in the textbook. You may NOT use notes, or cheat sheets for the final. The final must be completed in class on the day of the final, unless previously arranged with the instructor.

*Extra Credit opportunity

Note: Attendance will not be counted toward your final grade, however there will be a total of 4 pop quizzes offered for extra credit at 5 points a piece. These quizzes will be offered in class and cannot be made up late.

Total points: 300 points.

Grade Distribution: A=93% and above, A-=90-92%, B+=88-89%, B=83-87, B=80-82%, C+=78-79%, C=65-77%, D=60-64%, F=59% and below

Late Policy:

Late work will be accepted with point reductions. For every class period that passes after the assignment due date, your assignment will lose 25 %. Therefore, after 4 classes/two weeks your assignment will not be accepted:

1 class period late: 75% credit 2 class periods/1 week late: 50% credit

- 3 Class periods late: 25% credit
- 4 Class periods late: 0% no credit given.
 - Presentations cannot be made up late.

• Extra Credit pop quizzes cannot be made up late
