Class Schedule:

DAY 1: Introductions, Establish student goals, Prescribed instructional plan, Independent and Teacher-led work; CASAS enrollment

DAY 2: Listening skills, Communication barriers, Speaking positively, Verbal communication skills, Body language, Email and telephone skills.

DAY 3: Barriers to effective communication, Identifying non-verbal signals, Difficulty in learning to become a better listener.
