### **Disruptive Classroom Behavior**

Student behavior or speech that disrupts the instructional setting will not be tolerated. Disruptive conduct may include, but is not limited to: unwarranted interruptions; failure to adhere to instructor's directions; vulgar or obscene language; slurs or other forms of intimidation; and physically or verbally abusive behavior. ### **Emergency Procedures for Humboldt County Correctional Facility**

Roving Officers will escort all visitors out of the building, using the appropriate evacuation routes. The Roving Officers will verify the visitor's identification prior to letting them out of the facility. The inmates are returned to their appropriate housing unit and then relocated by correctional staff if the need is determined by the incident commander.

Class Schedule:

DAY 1: Introductions, Establish student goals, Prescribed instructional plan, Independent and Teacher-led work, Five ethical principles (purpose, pride, patience, perspective, persistence), Ethical dilemmas (e.g. lying, cheating, stealing), Three-step checklist for identifying unethical behavior (Is it legal? Is it a 'win-win' situation? Would you do the same thing if a loved-one, boss, or a friend was watching, or if it would be on the front page of the paper tomorrow?).

DAY 2: Cultural and religious values can influence the ethical decision-making process, Personal and work ethics should be authentic and meaningful, These topics may be subjective.

DAY 3: Barriers in making good ethical decisions (e.g. power differentials, pressures, judgment, expectation), Ways to overcome ethical barriers (e.g. setting clear policies and procedures, separation of duties, effective monitoring, transparency, clear mechanisms for reporting wrongdoing).

\*Because this is a self-paced course, students may begin the course work independently of other students' progress.
