Class Schedule:

DAY 1: Introductions, Establish student goals, Prescribed instructional plan, Independent and Teacher-led work

DAY 2: 1. Understand the five basic principles of good cash handling. 2. Understand the risk and controls in handling cash. 3. Know how to collect, secure, reconcile and document cash transactions appropriately. 4. Know how to make change accurately. 5. Identify how to troubleshoot cash-related discrepancies. 6. Know how to use a cash register.

DAY 3: 7. Understand the importance of knowing the cash handling policies & procedures of the place you work. 8. Understand the roles and responsibilities of both employee and management. 9. Understand the flow of cash and the role of the service staff in different establishments. 10. Identify different banking systems and how to use them. 11. Know how to organize and separate tips. 12. Explain how to handle “dine and dash” situations.

*Because this is a self-paced course, students may begin the course work independently of other students' progress.
