Class Schedule:

DAY 1: Introductions, Establish student goals, Prescribed instructional plan, Independent and Teacher-led work

DAY 2: The value of good time management skills, Preparing and analyzing a self-diagnosis to determine where one's time goes, S.M.A.R.T. principles (Specific, Measurable, Attainable, Realistic, and Timely).

DAY 3: Time wasters (e.g. excessive e-mail checking, poor prioritization, disorganization, procrastination, inability to say "no", perfection), Tips and techniques to better manage time (e.g. keep a 'to-do' list, break down large tasks into small tasks, tackle projects early in the day, leave time for unexpected demands), R.A.F.T. productivity plan (Refer, Act, File, or Trash).

*Because this is a self-paced course, students may begin the course work independently of other students' progress.
