Roving Officers will escort all visitors out of the building, using the appropriate evacuation routes. DAY 3: Individual and group decision-making, Factors to keep in mind when making decisions, Problem-solving techniques, Blocks to problem-solving (e.g. perceptual, cultural, environmental, emotional), The role of creativity in problem-solving and decision-making.

*Because this is a self-paced course, students may begin the course work independently of other students' progress.
